### **Sewer Repairs: Week of September 30 to October 5**

*Pima County, Ariz.* – The Pima County Regional Wastewater Reclamation Department and its contractors will conduct sewer repairs at various locations between September 30 and October 5, including those listed below.

#### **Achen-Gardner Construction working between 6:00 a.m. and 6:00 p.m.**

- **2000 E. River Road.** Sewer pipe cleaning, 9-30. Sewer pipe lining, 10-1.
- **9187 N. Placita San Isidro.** Sewer pipe lining. 10-2.
- **9800 N. Camino Del Grillo.** Sewer pipe lining. 10-3.
- **1896 W. Misty Hollow Lane.** Sewer pipe lining. 10-4.
- **Hartman Lane in Marana.** New sewer installation on Hartman Lane between Cortaro Farms Road and Linda Vista Boulevard is now complete. For additional information, visit [www.sewerimprovements.info](http://www.sewerimprovements.info).

#### **B&F Contracting Inc. working between 6:00 a.m. and 6:00 p.m.**

- **7474 E. Speedway Boulevard.** Drop off/begin fusing sewer pipe for the Pantano Interceptor Project (Broadway/Speedway/Loop project). Traffic restrictions on E. Speedway and the Loop will be in place. Project duration: 6-8 weeks. This is for the week of 9-30 to 10-5. Weekly project updates will follow.
- **4390 E. Grant Road.** Remove and replace sewer pipes. 10-1 to 10-3.

#### **KE&G Construction, Inc. working between 6:00 a.m. and 6:00 p.m.**

- **608 N. Contzen Avenue.** Manhole installation and adjustments. 9-30 to 10-1.
- **2933 W. Salvia Drive.** Manhole repairs. 10-2.
- **1253 N. Placita De Almas.** Manhole repairs. 10-2.
- **2773 W. Avenida Azahar.** Manhole repairs. 10-3.
- **1900 N. Oracle Road.** Manhole repairs. 10-3.
- **199 W. Washington Street.** Manhole repairs. 10-4.
- **426 N. Court Avenue.** Manhole repairs. 10-4.

Construction equipment/work crews/flaggers will be on site at the various locations; all traffic should slow down, heed signage, and exercise caution when navigating through construction zones. It is unlawful for citizens to move traffic control devices within a construction zone, and doing so could result in a fine. **Construction times are approximate and are subject to change in the event that unforeseen conditions or inclement weather cause delays or postponements.**
