Statement of Probable Cause continued: An email circulated to staff members in February 2022 with Dervish's photograph with instructions to call 911 if he were to return to the building.			
Approx three hours after the shooting, Dervish was stopped by police traveling southbound on AZ Highway 85 toward Mexico approx. 30 miles south of Gila Bend. Dervish refused to stop his vehicle for approx. 2-3 miles with police attempting to stop him using lights and siren. He was subsequently stopped using a "PIT" maneuver. A search of Dervish's vehicle revealed a 9mm handgun loaded with ammunition consistent with the approx. 11 shell casings found at the murder scene.			
Post-Miranda but prior to questioning, Dervish made the following spontaneous statements, "I hope he's okay, probably wishful thinking.", "I just felt so disrespected by that whole department.", "A woman wouldn't have done this.", and, "I was going to kill myself, shoot myself, but I couldn't."
