Related Issues

EnerGov Permit System Fee Alignment

- The new permitting system "Go-Live" is October 31
- Current Fees must be aligned to function in the new system
- Public Hearing was held in 2021
- Adoption of the Aligned Fees is scheduled for September 27 M&C
- The Proposed Rates and Fees are changes to these Aligned Fees

Proposed Rate Adjustments

Residential Collection Fee

- \$3.25/month 01/01/23
- \$3.00/month 01/01/24

Commercial Collection Fee

- Increase by 10%
- Effective 01/01/23

Landfill Disposal Fee

- Increase by \$3.00
- Effective 01/01/23

Why?

- Increased operational and maintenance costs
- Increased equipment costs
- Expanded services

Tucson Water

Proposed Rate Adjustments:

- CAP Surcharge increase from \$0.70 to \$1.00/Ccf on 01/01/23
- 5.5% ATB increase each of next four years starting 07/01/23

When?

Last rate increase effective 07/01/19

- Increased cost of water resources due to drought declaration
- Increased cost of replacing aging infrastructure



Proposed Rate Adjustment

- Daily Garage & Lots Fees
 - Increase by \$1 1/1/2023
 - Increase by \$1 1/1/2026
- Monthly Garages & Lots Fees
 - Increase by \$5 (see table)
 - Effective 01/01/2023
- Annual On-Street Permit Fees
 - Increase by \$75 7/1/2023
 - Increase by \$25/year 7/1/2024-2026

- Market Competition
- Cost of Service Delivery: security, staffing, utilities
- Deferred Maintenance and Repairs on Parking Garages
- System Improvements





Park Tucson – Enforcement Time Changes

- 1. Enact paid on-street parking in the Mercado District
- Higher parking demand from ongoing development in the area

Timeline - Outreach to merchants/residents (Aug. 2022); implementation (Jan. 2023).

- 2. Extend existing meter enforcement times into evenings and weekends Current Days/Times: Monday to Friday, 8 a.m. to 5 p.m.
- Hours have not changed since inception of metered parking in 1950's.
- Tucson one of few cities of its size that does not charge evenings/weekends.
- New hours to vary by district/sub-district, day of week, based on occupancy
- At least 6 p.m., with later nighttime hours for high-demand parking areas
- Add Saturdays in all districts; add Sundays in some areas

<u>Timeline</u> – Outreach to districts and public (Fall 2022); implementation varying by district, early 2023-2024.

Parks & Recreation

New Fees

- Commercial Use of Parks allow new and expanded use of parks and allow small business development
 - Up to \$30 per day
 - Up to \$200 per month
 - Up to \$500 per quarter
- Sports Field Use Fee to allow accountability of reservation and encourage releasing of fields for increased use
 - \$1 an hour aligned to Pima County rate

Changes to Existing Fees (Last modified in 2010)

- Light Use Fee \$8 per hour align to Pima County current rate
- Ramada Reservation Fee respond to demand associated maintenance and align applicable fees to Pima County rates
- Leisure Classes update calculation formula no fee increase, allowing discount program to apply
- Tween Summer Program apply an 8-week program fee, discount eligible, that keeps cost the lowest in the market
- Remove Neighborhood Center Fees barrier-free general admission to enjoy smaller center locations
- KIDCO Increased cost of service, while staying the lowest cost after-school and summer programs. Discount fee applicable.
 - \$70 per month for Afterschool Program
 - \$500 for 8-week summer program

Development Fees

Proposed Rate Adjustment

- 3.5% increase on 01/01/23
- 3.5% increase on 01/01/24

When?

Last rate increase (10%) occurred in 2008

- Meet permit review timeframes and customer service goals
- Generate sufficient revenue to fund allocated positions
