I was sent the email which contained the threat. This email was sent to and This email was sent from Todd Olson ToddPOLson@live.com on 10-22-22 at 1031 hrs. The subject of the email was Election Integrity. The email read:

Attention ALL Corrupt and Treasonous Government Officials....

If you continue to with the integrity of the AZ Elections.....

I guarantee you, We the People will remove you from office....

Additionally, if you own a home.....

We will find you through the Tax Assessors Website...

Remember the French revolution of 1799??.....

When received this email sent it to Sheriff Dannels and County Attorney Brian McIntyre. wrote that considered this email to be a direct threat to life.

I looked in our local system (Spillman) and was not able to locate Todd Olson. I searched the MVD database and found two (2) Todd P Olson's in Arizona. One was out of Peoria, AZ and the other was out of Tucson, AZ.

I searched the (third party open source research) and was not able to connect this email address to the subjects located in the MVD database.

It should be noted the email address used was live.com. This is a Microsoft-based email and this domain was discontinued in 2012 but is still active. Meaning this email address has been around for a while.

I drafted a search warrant and presented it to Judge Curfman who reviewed and signed the search warrant.

I contacted \_\_\_\_\_ and issued \_\_\_\_\_ victims' rights.

I sent the search warrant to Microsoft. Once the information from Microsoft is received a supplement will be completed.

I contacted Microsoft who told me I would need to download a zip program to view the files. It should be noted that I can not download programs on my County computer without I.T. approving it. It should also be noted these files were password protected and the password was on the Portal.

On 10-24-22, at approximately 0800 hrs, I contacted I.T. who was able to install the zip program on my computer. I went to log into the Microsoft Portal but it would not load.

At approximately 0821 hrs, the search warrant was returned to JP#5.

On 12-25-22, at approximately 1224 hrs, I received a message from  
advising me to turn this case over to Sierra Vista Police Department due to a conflict. I was asked to finish the search warrant and turn the case over.

At approximately 1532 hrs, I logged back into the Portal and was able to locate the files and password. I was able to open the files and use the password to view them. I located two (2) Excel forms with account information and I.P. information.

This case was turned over to Sierra Vista Police Department for further investigation.

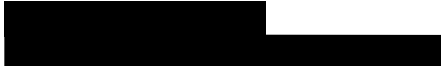

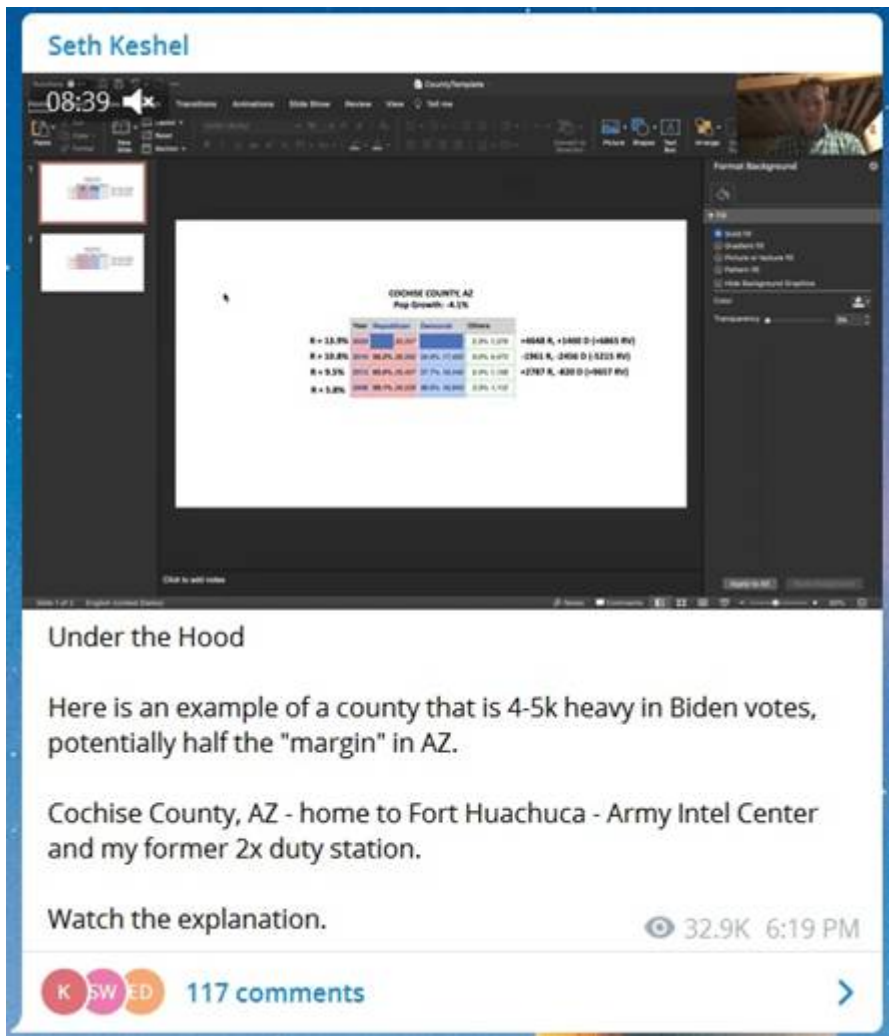

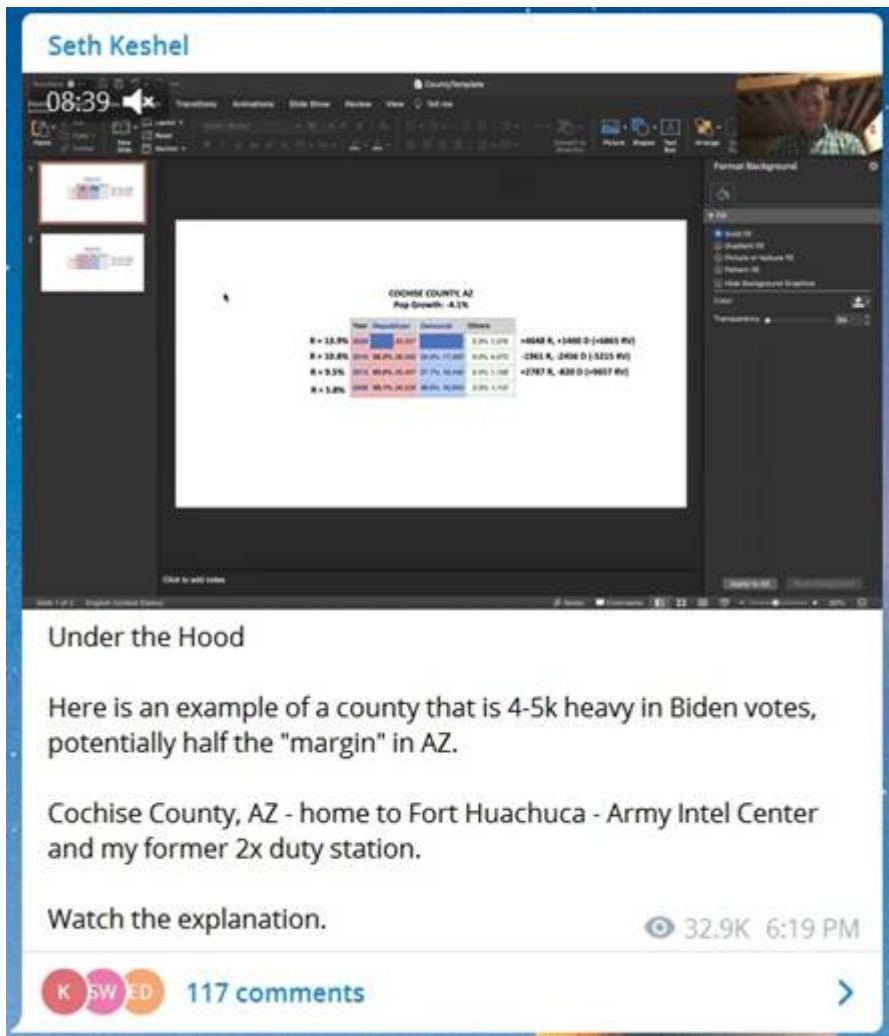
