




Target locations – Densely populated Christian Communities

- From Southern California based HQ, generate, distribute, and manage relationships throughout California, Arizona, Nevada, and the greater Denver, Colorado areas.
- Hire regional teams in California, Arizona, Nevada, and Denver, Colorado to make contact with local churches and schedule informational events and activities.
- Digital Christian Outreach can be redirected to additional markets, but will overlap with grassroots activities
- California has 40M residents and roughly 18M estimated churchgoing Christians, Arizona's 2 largest regions (Phoenix/Tucson south and Flagstaff north), Nevada (Las Vegas and surrounding cities in the south and some Reno in the North), and the Denver/Boulder/Colorado springs Colorado area



Southern California Headquarters

- Riverside Headquarters
 - Co-located near digital firm Raincross to better coordinate messaging and strategy daily.
 - Houses Pastoral Video / Podcast Recording studio
 - Will use multiple Pastors and guest pastors to record different messages
 - All messages recorded in multiple languages for US churches who speak additional languages
 - English, Spanish, Chinese, Vietnamese, Russian
 - (Possibly) Japanese, Korean
 - Houses Pastoral resource coordinator
 - Houses Social Media team
 - Houses entire Admin team
 - Houses purchasing team and stores the Mobile 10/7 Trailer

The Travelling Team

- Operates and sets up the mobile 10/7 experiences at churches and Christian colleges
- The California Region must travel to Phoenix, Flagstaff, or Las Vegas and Reno. 8 hour+ commutes when churches agree to host us.
- Denver may be to far to deploy the 10/7 Mobile trailer unless we get budget approved for a second trailer.
- Set up outside major Christian events, colleges, churches, concerts.





The 10/7 Experience

- Custom build Trailer by professional Hollywood set designers
- Reversable exterior walls allow for interactive 6:29 experience by walking to the side of the trailer.
- Opposite side has a slide-out or stage flooring to invite attendees to come into the trailer from the side.
- Mounted Survive to Tell VR experience interiorly with seating
- Mounted Generator with wired outlets interiorly.
- Exterior display tent allows for crowds to visit without being too cramped, 10/7 sections, information sections with pro-Israel materials, scenes from the Nova festival and other recognizable 10/7 sites
- · Interior wall-length mounted TV with updated information, pro-Israel media
- Wrapped with images of Israel or the Western Wall
- Call to action outside the exhibit using biblical messaging

College Activities

- There are 30+ Christian Colleges in CA, 6 in Arizona, 2 in Colorado, and no Christian Colleges in Nevada
- Hire on-campus student to table events and recruit student volunteers
- Asks students to sign the pledge drive
- Hands out SWAG and information about social media channels
- Requests 10/7 display on campus and sets up meetings for state leaders

Activities – Digital backup

- Will develop website and maintain through a 1-year period, even if the bulk of grassroots activities are complete within 4-6 months
- Will geofence same targeted churches running digital ads that are both pro-Isreal and anti-Palestinian
- Will geofence attendees of our events to follow up with social media advertising.
- Will identify Social Media influencers to hire in exchange for favorable coverage
- Will manage the creation and shooting of sympathetic TV style commercial(s)
- Will distribute materials via social media
- Will optimize SEO traffic so that favorable coverage is increased and unfavorable information is decreased.

Precision Engagement

Precision location-based targeting ensures only our target market sees ads, maximizing the effectiveness of our outreach

Additional Possible Options

- There are 5 additional options if there was an additional budget that we could ask for.
 - Expanded Digital Reach to additional States The media campaign has already prepared the digital files, we could use the same targeting to target churches in other media markets. The best region to target would be Texas which has a large number of megachurches like California.
 - A Second Mobile 10/7 Experience. If our activities go well, we could see a need to build a second Mobile trailer and get another towing vehicle with some additional staffing.
 - Pastoral Resource Packages to 3 additional states:
 - The biggest state would be Texas again, but the Pastoral Resource Packages range from \$20-\$30 each to print and an additional cost to ship. There are huge numbers of evangelical churches in Texas, Utah, and Wyoming that we are not targeting but who might be open to our resources and educational materials.
- I did not want to be too aggressive with the budget, but if there was a way to get these resources, we would absolutely put them to use to build an even better program.
